

**BY-LAWS
HOWARD ALL ACTIVITIES
BOOSTER CLUB**

ARTICLE I-NAME

Howard All Activities Booster Club

ARTICLE II-PURPOSE

1. To promote and support all activities of the Howard School District.
2. To exemplify sportsmanship within the student body and the community.

ARTICLE III-MEMBERSHIP

1. Members of the Howard All Activities Booster Club will include all parents of Howard students that are involved in any school activity and any interested adults in the community.
2. The Booster Club year will run from the beginning of one school year and end @ beginning of the next school year.

ARTICLE IV-OFFICERS

1. The officers of the organization will consist of a Chairman, Vice Chairman, Treasurer, Secretary, and immediate past Chairman.
2. The length of term will be one year for the Chairman, and then will be retained for the past Chairman position. The Vice Chairman will be one year and then move up to the Chairman position. The Secretary & Treasure appointments will have no term limit. There will be annual elections at the August meeting.
3. Duties of the Officers-
 - A. The Chairman shall call and preside at all meetings.
 - B. The Vice Chairman shall act in the chairman's capacity when the Chairman is absent.
 - C. The Secretary shall record all minutes and transactions of each meeting. The minutes must be approved at the next meeting.
 - D. The Treasurer shall record, and account for the funds of the organization. A report shall be given and approved at each meeting. Funds will be dispersed through organizations non-profit established account with the Howard School District. Expenses will be paid after voucher approval by the Officers.

4. Election- Nominations for officers shall be made from the floor @ the August meeting, with the new officers presiding over the Sept. meeting.
5. Vacancy- If a vacancy occurs within the officers during the year, the vacancy shall be filled by a majority vote of nominations of the members present. They will complete the current term until July 31st.

ARTICLE V-COMMITTEES

15. Committees may be designated as the Booster Club and/or officers see fit. Such committees will be appointed by the Chairman.

ARTICLE VI-MEETINGS

1. The Howard All Activities Booster Club will meet monthly on the second Wednesday of the month. The time and place will be posted in the Miner Co. Pioneer.
2. A Quorum for a club meeting shall consist of at least five members and two officers.

ARTICLE VII-AMENDMENTS OF THE BY-LAWS

1. Current by-laws can be amended at the August meeting, by 75% vote of the Howard All Activities Club members present.
2. Amendments need to be presented to the members of the club for review prior to the August meeting.

ARTICLE VIII-PARLIMENTARY AUTHORITY

1. The rules contained in Roberts Rules of Order shall govern the business meetings of this club in all cases where they are not inconsistent with these by-laws.
